## Hosting Information Sessions - A Connection that Works!

When I began my work as Community Outreach Facilitator with the Connections that Work program one of the stated goals was “hosting Information Sessions”. This coordination of Information Sessions with various service agencies at Dartmouth food banks allows these agencies to share their story and service with clients.

Two years later over 40 Information Sessions have been held at the four food banks I regularly attend. Here’s what that looks like; an agency that offers services in literacy, employment, education, computer training, etc...would arrive 15 minutes before the food bank opens, they would typically set up with a display board and brochures in a corner of the Hall. During the gathering time the food bank coordinator would call on the agency representative to share in 2 minutes what that organization can offer clients. For the next hour clients waiting for their number to be called would circulate around the table and ask questions, picking up brochures for themselves and others they know who might be interested.

Ten different agencies have participated in these Information Sessions for clients held at the food banks and they include; The Career Development Centre on Wyse Rd, the HRM downtown police officer, Lake City Employment, Solutions Learning Centre (formerly Dartmouth Work Activity), Team Work/Work Bridge, Mike Savage MP, the Dartmouth

On July 15, 2010 the Canada Revenue Agency announced that The Public Good Society qualified for Registration as a Charity.

Charitable status means that The Public Good Society is able to issue receipts for donations under the Income Tax Act.

## **Consulting the Community**

On July 29, The Public Good Society hosted an open discussion at the Christ Church Hall on Dundas St. The discussion began with a question, "where do you see The Public Good Society's efforts being best employed?" the evening brought together a diverse group of Dartmouth citizens from many walks of life, yet when asked, the response was mutual. Within the first fifteen minutes of the discussion, we had come to a consensus (a process we had expected to take up close to half of our time together). Just as we had expected, Housing Issues, and more specifically, Affordable Housing seems to be on Dartmouthians minds lately, with the theory that "If you don't have a roof over your head, you don't have much more than a hope and a prayer".

As the evening proceeded, members of the discussion circle were introduced to the realities of the struggles faced by those effected by the dilemma of Affordable Housing. These realities were shared by service providers, politicians, and first voice individuals, living the struggle day to day. Energy rose as stories, theories and ideas were shared, and by the end of the discussion, The Public Good Society had committed to hosting an Affordable Housing Forum in the near future. Such a forum would bring together representatives from all parties effected by Affordable Housing, and would welcome the broader community of the HRM, all in pursuit of making affordable housing a reality.
